

The Lloyd Railroad Depot: Several of the NMRA SSR Northen Division in Tallahassee have continued to volunteer to restore the Lloyd Railroad Depot (<a href="https://gulfwindnrhs.org/LloydDepot.html">https://gulfwindnrhs.org/LloydDepot.html</a>) The Lloyd Railroad Depot is a historic depot building in Lloyd, Florida. Built in 1858 by the Pensacola and Georgia Railroad, it is the oldest brick railroad station in Florida and one of only two surviving railroad depots in the state built prior to the start of the American Civil War. The building closed in 1966 after its owner at the time, the Seaboard Air Line Railroad, discontinued service there and donated it to the Jefferson County Historical Society. A few years later, ownership was transferred to the Gulf Wind Chapter of the National Railway Historical Society, who own it to this day. On December 2, 1974, it was added to the U.S. National Register of Historic Places. The structure is located near the junction of SR 59 and Old Lloyd Road. It is currently used as a post office.

#### \*\*\* Rich Mahaney – will be presenting the 13 Clinics below \*\*\*

- 1. Thursday Night Hotel Clinic 7PM Potatoes This new presentation looks at the potato from growing to the final product in an "audience participation" clinic format. The students will participate in selecting railroad car needs and traffic, transporting chemicals, growing products, railroad car traffic, the making of consumer products from potatoes, potato industries, and more. Lots of fun, answer questions, fill out flip charts on the wall and discuss the answers with the group for comparison answers and different answers.
- **2. Intermodal 101 For Model Railroaders** This 60 minute presentation looks at intermodal operations, intermodal box and tank containers, truck trailers, intermodal facilities, intermodal and truck trailer equipment and transferring the prototype to the model railroad.
- **3. Interesting Flat Car Loads** This 45 to 60 minute presentation looks at a variety of "stuff" that is transported on flat cars by railroads. It answers the question, "do they really transport that "stuff" on flat cars for real"? It will give the modeler some ideas for their own flat car loads to build.
- **4.** "Quick Industries" for Your Model Railroad This 60 minute presentation is designed give model railroaders industry ideas for their model railroad that can be assembled in several evenings (or days) of work. These industries can quickly increase railroad traffic and new customers. Examples of real facilities and model railroad examples are used to make the points.
- **5.** Creating Other Interesting Industries on Your Model Railroad Layout In this 60 minute presentation we look at other industries and buildings made from structural members and backdrops involved with layout construction.

- **6. Railroad Cars That Transport Hazardous Materials -** This 60 minute presentation provides the model railroader with a basic understanding of what kinds of railroad cars transport what kinds of solids, liquids and gas types of hazardous materials Discussion and photos illustrate the many types of railroads cars that are used to transport hazardous materials safely across North America every day, along with their placarding.
- 7. 1950's Refrigerator Car Layout Operations on Model Railroad Layouts After looking at and photographing refrigerator cars, icing platforms, cold storage and other buildings and operations on many layouts, this clinic presents some of the best ideas and modeling I have seen that capture the feel and operations involved with refrigerator car operations in the 1950's.
- 8. "OMG" Prototypical Accessories To Buildings and Communities For Model Railroads!

   Take a look at the accessories and details that you are missing on your buildings and in your communities that stand out when you look around or travel around. The only thing you can say when you see these images is "OMG"! Most of these additional features can probably come from the scrape boxes or parts and pieces underneath your layout or on your work bench. You may not have much to buy when you through "spare stuff". (60 minutes)
- **9. The Smells of Model Railroading!** A 60 minute look at ways to add another aspect of scenery to your model railroad "smells". Did you know there is a candle that smells like fresh cut wood?
- **10.Making "Stuff" for Model Railroaders** How is "stuff" made? A look at how "stuff" is made is made so that the model railroader can understand the correct use of railroad cars for delivery of solids, liquids and gases by railroad cars to industries. Several products and industries will be case studied and a process to do this will be discussed for the model railroader to use. The primary goals are to get it right and do it right for better rail car movement and use and be prototypically correct.
- 11. Five Busy Railroad Traffic Locations for Your Layout (Interchanges, Freight Houses, Team Tracks, Bulk Transfer Facilities and Rail Car Repair Facilities This clinic looks at five busy locations that can be built on your layout to increase rail car operations, can use any kind or type of car on your layout, create rail car traffic and operations, can be used to support industries that don't have a railroad spur and can fit into a small space on your layout.
- **12."Big Pipes" Adding pipe details to various types of industries.** This clinic looks at very large pipes on industries that are used to move solids, liquids, and gases. Besides serving as an important part of the industrial process in manufacturing, they also look cool. Get some modelling ideas for industries on your layout.

13.Understanding how stuff is made, how the railroad supports that with car placement, just in time deliveries, modeling industries and operations - This clinic deals with industry design and operations; how products are made and assembled involving solids, liquids and gases; railroad operation to support industries with parts and shipping; "just in time" operations, car placement at industries and railroad operations and traffic. Model railroaders need to do research into the industries and products they want to model, it is not just enough to just place some buildings or a siding on your layout.

#### THE CABOOSE CHALLENGE

The Caboose Challenge started when Rich Mahaney (Gobles, Michigan) came down to present 4 clinics at one of our Eastern Division Workshop. When I met Rich, we started talking about how to get more people involved in bringing models to our convention. He told me about a Caboose Challenge they ran for one of their NMRA, North Central Region Conventions, which is centered around the Great Lakes states of Michigan, Ohio, and Indiana. Rich did a Caboose Challenge Presentation at the 2022 SSR Convention Banquet last year, and we had 30+ people immediately accept the challenge.

The Caboose Challenge is free and open to anyone coming to the SSR 2023 High Speed Rail Convention in Plant City. Everyone from young to old, NMRA Members, non NMRA Members, you just need to be willing to build a Diorama any size up to 24x24", any Scale (N, HO, S, and O) of a caboose in its "2<sup>nd</sup> Life After the Railroad". There will be example pictures in the T-Key and on our (SunshineRegion.Org) Website.

The winners will be chosen by a "People's Choice" vote, the Ballot will be in your Goody Bag, so please look for it. There will be 4 prizes to be presented to the winners. The Grand Prize will be a 2024 Convention Registration and Banquet ticket. Second Prize will be a 2024 Banquet ticket, Third Prize will be \$25 off their 2024 Convention Registration, and Fourth Prize will be \$20 off their 2024 Registration. *Disclaimer: Prizes are non-transferrable, non-refundable, and have no cash value.* 

There will be a Special Clinic Room set up for display of the Caboose Dioramas. You will need to fill out a Model Entry form as the Model Diorama will only have a number. Caboose

## THE ROUNDHOUSE - 3D PRINTING 101



3D printing technology has been around since the 1980s, but it has only recently become more accessible and affordable for use in homes and small businesses. This technology has advanced significantly, making it possible to print objects with a wide range of materials, from plastic and metal to food and even living tissue, but what can we "print" for our

#### railroads?

The 3D printing process typically starts with the creation of a 3D model using specialized software or a 3D scanner. The digital model is then sliced into thin layers and sent to the 3D printer, which uses the information to create the object layer by layer. The printing material is deposited by a print head or nozzle that moves along the x, y, and z-axis, building up the object as It goes.

There are several types of 3D printing technologies, each with its own strengths and weaknesses. Some common types of 3D printing technologies include fused deposition modeling (FDM), stereolithography (SLA), selective laser sintering (SLS), and digital light processing (DLP).

3D printing has a wide range of applications, from rapid prototyping to manufacturing complex components for aerospace and medical industries. It has also revolutionized the production of customized products, such as prosthetics and dental implants, and has even been used to print entire houses.

Despite its many advantages, 3D printing also has its limitations. The technology is still relatively slow and can be expensive, and the quality of the printed objects can be affected by factors such as the type of material used and the complexity of the design. However, as the technology continues to advance and become more accessible, it is expected to become an increasingly important tool for manufacturing and innovation in a wide range of industries.

The main difference between filament and resin 3D printers is the material they use to create objects and the maintenance methods.

#### **FILAMENT**

Filament 3D printers use a spool of plastic filament, typically made from PLA or ABS, which is melted and extruded through a nozzle to build up an object layer by layer. Filament 3D printers are often more affordable and easier to use than resin printers, and they can create larger objects with more color options. However, the resolution of filament 3D printers is typically The Telegraph Key

lower than that of resin printers, meaning that the surface finish of the object may not be as smooth.

Maintaining a Filament 3D printer is essential to ensure that it performs optimally and produces high-quality prints consistently. Here are some maintenance tasks that are typically required:

- 1. Cleaning: 3D printers require regular cleaning to remove any dirt, dust, or debris that may affect the quality of the prints. The printer's build plate, nozzle, and extruder should be cleaned regularly with a soft cloth and isopropyl alcohol.
- 2. Lubrication: The printer's moving parts, such as the rods and bearings, should be lubricated periodically to prevent wear and tear and ensure smooth movement. This can be done with a small amount of lubricant oil.
- 3. Filament management: Proper storage of filament is important to prevent it from absorbing moisture and causing issues during printing. Filament should be kept in a dry and cool place, and only enough should be removed from the spool for a single print to prevent tangles and knots.
- 4. Leveling the build plate: The printer's build plate should be leveled to ensure that the first layer of the print adheres properly to the plate. This should be done regularly as the plate can shift during transport or use.
- 5. Nozzle maintenance: The printer's nozzle should be checked and replaced if necessary to prevent clogging and ensure proper extrusion of the filament.
- 6. Firmware updates: The printer's firmware should be updated periodically to ensure that it is operating at its best.
- 7. General inspection: Regular inspection of the printer for loose screws, damaged parts, and worn belts or gears can help prevent more serious issues and ensure the printer is working properly.

#### **RESIN**

Resin 3D printers, on the other hand, use a liquid photopolymer resin that is cured with UV light to create an object. The resin is contained in a vat and the printer uses a build platform to gradually raise the object out of the resin. Resin 3D printers are capable of producing very high-resolution objects with fine details and smooth surface finishes. However, they are typically more expensive than filament printers, and the resin can be messy and difficult to

work with. Also note that the resin printer is the item on the left in the picture while the curing station is on the right. The curing station is needed to harden the resin using UV light.

Resin 3D printers require specific maintenance to ensure optimal performance and to extend the lifespan of the printer. Here are some maintenance tasks that are typically required:

- 1. Cleaning: Resin printers require frequent cleaning due to the mess created by the resin. All parts that come in contact with the resin, including the build plate, resin tank, and resin cartridge, should be cleaned regularly with isopropyl alcohol or a specialized resin cleaner.
- 2. Resin tank replacement: The resin tank has a limited lifespan and should be replaced periodically, as it can become scratched and hazy over time, affecting print quality.
- 3. Build plate leveling: The build plate should be leveled regularly to ensure that the first layer of the print adheres properly to the plate. This should be done before each print.
- 4. Resin filtering: Resin should be filtered before and after each print to remove any solid particles or impurities that may affect print quality.
- 5. UV lamp replacement: The UV lamp in the printer should be checked and replaced if necessary to ensure that the resin cures properly.
